

NOTIFICATION

In exercise of the powers conferred by Sub-Regulation (2) and (3) of regulation 30 and 43 of the Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010 read with section 21 of the General clauses Act, 1897 (Central Act 10 of 1897) and in supersession of the earlier notifications or orders issued in this behalf, the Government of Karnataka, hereby directs 650 Volts as "Notified Voltage" to carry out the Periodical Inspection and Testing of Installations before commencement of supply or recommencement after shutdown for six months and above respectively except the installations covered under the Karnataka Lifts, Escalators and Passenger Conveyor Act, 2012 (Karnataka Act 9 to 2013) and rules made thereunder and also the Karnataka Cinemas (Regulation) Act, 1964 (Karnataka Act 23 of 1964) and rules made thereunder.

Provided that, the installations belonging to Government of India or its undertaking are excluded from inspection by the Electrical Inspector of the State.

**NOTIFICATION**

In exercise of the powers conferred by sub regulation (1) & (3) of regulation 30 of the Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010 read with section 21 of the General Clauses Act, 1897 (Central Act 10 of 1897) and in supersession of the earlier notifications or orders issued in this behalf, the Government of Karnataka hereby directs; that where an installation in the State of Karnataka is already connected to the supply system of the supplier or trader, every such class of installation specified in column (2) of the Table below shall be periodically inspected and tested by the authority specified in column (4) at such intervals specified in column (3) thereof by the Electrical Inspector or any officer appointed to assist the Electrical Inspector.

Provided that, the installations belonging to Government of India or its undertaking are excluded from inspection by the Electrical Inspector of the State.







In exercise of the powers conferred by Sub-Regulation (1) and (2) of Regulation 43 of the Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010 read with section 21 of the General Clauses Act, 1897 (Central Act 10 of 1897) and in supersession of the earlier notifications or orders issued in this behalf, the Government of Karnataka, hereby directs; that where an installation having Voltage Less than 650Volts (Excluding the installations covered under Notification- I, II, III & IV) in the State of Karnataka shall be inspected, tested and self certified by the owner of the Installation before commencement of supply or recommencement after shutdown for six month and above for ensuring observance of safety measures as specified in the above regulations and such owner shall submit the report of self certification to the concerned Electrical Inspector.

Provided that, under proviso to sub regulation (3) or regulation 43 the supplier or owner or consumer has the option to get his installation inspected and tested by the Electrical Inspector of the State.


